Little House update

The Little House (LH) project reached a milestone with its final walkthrough on March 20, 2024. Below are pictures from the 'punch walk' that took place on March 27.



The LH space is designed to serve children from infants through PreK, offering areas for Light and Shadow exploration, an Art Center, a Learning Kitchen, an Infant Motor space, and a teacher/adult-only area. The space must first pass the CDHS licensing inspection before it can become available for children.

Health Inspection- passed! PASSED

To uphold our high standard of quality in early care and education, we must adhere to multiple rules and regulations set by the state of Colorado, including those from CDHS and CDPHE. We underwent a semi-annual inspection early last month (inspections are unannounced), and we are pleased to report that we met expectations across various areas, from children's immunization to classroom safety and building conditions. The CDPHE inspector remarked, *"If I had a young child, I would send my child to Fisher !"*

"NAEYC first established the Week of the Young Child® in 1971, recognizing that the early childhood years (birth through age 8) lay the foundation for children's success in


