

SCHOOLCOUNSELING@DENVER STATE LICENSURE INFORMATION

The SchoolCounseling@Denver MA degree program leads to a Master of Arts in School Counseling. The program currently leads to eligibility for a School Counselor Credential within Colorado.

This 90-quarter credit specialized degree program fulfills the academic eligibility requirements for Colorado (CO) state licensure as a school counselor. According to a revision of the <u>CO Educator Licensing Act in 2016</u>, students applying for a school counselor license in the state of Colorado after July 1st, 2021, must graduate from a Council for Accreditation of Counseling and Related Educational Programs (CACREP) accredited program.

Effective July 9, 2020, CACREP, a specialized accrediting body recognized by the Council for Higher Education Accreditation (CHEA), has granted accreditation to the School Counseling MA degree program, within the Department of Counseling Psychology at the University of Denver. This accreditation is active through October 31, 2030.
